**NOTIFICATION OF ENTRY:**

1. The auctioneers give no undertaking to accept any lots entered for the sale. Receipt of this entry will be posted first class one week prior to the sale.
2. The saleground will be open for the delivery of lots prior to sale as per the Notice to Prospective Vendors.
3. All keys, documents (including manuals and registration documents) and small removable components are to be handed to the Auctioneers on delivery of items to the saleground

**PLEASE NOTE** – we cannot accept asbestos, worn or damaged tyres, old metal poultry cages/equipment, any form of gas cylinder, glazed items or used bathroom/kitchen fittings. Scrap cars/commercials will not be accepted. Sharp or dangerous edges must be protected and if appropriate lots securely propped and wheels chocked in position. Where there is no fitted support to the drawbar, this should be lowered to the ground. All electrical items are sold for scrap/spares unless stated otherwise. By signing the declaration the seller undertakes to indemnify bidders, purchasers and auctioneers against any liability arising out of inaccuracies in the information supplied as well as provide details of defects which could affect the health and safety of subsequent users.
